Solarvest Innovation Lab 2021 Terms and Conditions

The following terms and conditions apply specifically to Solarvest Innovation Lab 2021 ("SIL 2021").

The Solarvest Innovation Lab 2021 ("SIL 2021" or "Program"), sponsored by Solarvest Holdings Berhad ("Solarvest") is an incubation program to identify good business ideas that can be commercialized. This program aims to support the start-up's ecosystem in Malaysia, to promote innovation and entrepreneurship development.

ELIGIBILITY: SIL 2021 is open to any individual who is a permanent legal resident of Malaysia, 18 years of age or older on 1st Jan 2021, who is a founder and/or executive at a Malaysian-based start-up individual/company focusing on the fields below:

More than one Application is allowed for your company. Information on the Applications will be held highly confidential by Solarvest and will only be used by Solarvest in determining eligibility for participation in the Program and communication regarding the Program. Applications must be complete in order to be considered for the Program. Applications that are incomplete, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, or late, will be void. Once submitted, Applications will not be returned.

PARTICIPANT SELECTION CRITERIA: On or about 06/12/2021, Solarvest will shortlist Participating Companies from among all eligible entries received. Solarvest will select the Participating Companies based upon the following criteria:

• Applicability of the idea;

- Commercialisable of the idea;
- Inline with our target segments/industries

The Sponsor reserves the right, in its sole discretion, to select less than anticipated Participating Companies or extend the entry period if an insufficient number of eligible entries are received. The decisions of Solarvest are final and binding in all respects.

PARTICIPANT NOTIFICATION: The Participating Companies will be notified by email and phone if they are selected to participate in the Program. Individual Participants and Participating Companies will be required to execute an Affidavit of Eligibility and Liability/Publicity Release and Non-Disclosure Agreement prior to participating in the Program. If a potential participant cannot be reached, does not return required documents within the time requested, or does not agree to the Terms and Conditions of the Program, the opportunity to participate in the Program will be forfeited and another Participating Company may be selected according to the Selection Criteria above.

The Participating Companies agree to provide information or details for the Sponsor's use in all promotional and marketing campaigns. This includes giving the Sponsors permission to video and photograph at any stage of the Program and use the footage for an unlimited period of time.

PROGRAM TERMS AND CONDITIONS: This Program is subject to these Terms and Conditions.
